Due to limited funding, this application must be completed with as much detail as possible so we can determine priority and eligibility. Applications must be filled out completely and signed, to be considered. Please be sure to complete the form with one hundred percent honesty and accuracy.

Most of the terms mentioned below are Halachic requirements. Nonetheless, we mandate that they be signed on this form to avoid any possible misunderstanding or loss to the organization.

Chasdei Chashi L'Kallah provides beds and dinette sets. Please be aware that there are stricter guidelines to be eligible for the dinette sets.

- ▶ The beds are to be used only by the Chosson and Kallah, for the master bedroom. They are not to be used as an extra set in a second bedroom. Chasdei Chashi offers beds in 48 or 39 inch widths (54 inch beds are not offered.) We provide excellent, high quality beds which are being given for the Chosson and Kallah, not to be used temporarily.
- ▶ The Dinette sets (when given) include a beautiful table with six chairs, and are meant to be used as the main set for the couple (those purchasing/receiving a dining room set are not entitled to a dinette set.) Choices will be available upon approval.
- ▶ Our Rabbonim have set guidelines for the maximum wedding expenses incurred in order to be eligible for assistance. Those that spend over these guidelines will not be eligible. These guidelines include that the wedding take place in a Takana or low end hall. Additional guidelines include other wedding expenses. If they are above our set guidelines, CCL will be unable to assist.
- ▶ Beds are not to be put in storage. If the Chosson & Kallah are moving to Eretz Yisroel or living in a temporary apartment, they may not take the furniture, planning to use it at a later date. If the couple moves back within the year they may still be eligible to receive assistance.
- ▶ Please be aware that these items cannot be upgraded. That is, no extra money can be spent to receive more expensive beds or dinette sets.
- ▶ Please realize that it takes us approximately two weeks to verify eligibility, if references can be reached. Feel free to check that we received your application. Please provide references and numbers that are easily reached. If possible, provide more than one number for the reference such as a cell phone number. You will be contacted by email or phone once approved.
- ▶ Once you are approved, you will be contacted by the representative handling your order. From that point on, please be in touch only with that representative. Please make sure to send us the address of Chosson & Kallah in a timely manner, so that we can make arrangements for delivery.
- ▶ There is a minimum \$75 processing fee payable to Chasdei Chashi that must be paid before furniture will be delivered. There is an additional \$75 fee for receiving a dinette set.
- ▶ All information will be kept strictly confidential and will be used for Tzedaka purposes only.
